SECTION 4) FIRST-AID MEASURES

Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. Immediately call a POISON CENTER or doctor. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the POISON CENTER/doctor.

Eye Contact

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Stay uphill and/or upstream. Ventilate closed spaces before entering. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing. Evacuate and isolate hazard area and keep unauthorized personnel away.

Recommended Equipment

Wear chemical protective clothing and positive pressure self-contained breathing apparatus (SCBA). Wear liquid tight chemical protective clothing in combination with positive pressure self-contained breathing apparatus (SCBA).

Personal Precautions

SECTION 7) HANDLING AND STORAGE

General

Wash hands after use. Do not get in eyes, on skin, or on clothing. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. Eyewash stations and showers should be available in areas where this material is used and stored All containers must be properly labelled. Do not breathe vapor or mist.

Ventilation Requirements

Storage Room Requirements
