SECTION 4) FIRST-AID MEASURES

Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. Immediately call a POISON CENTER or doctor. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the POISON CENTER/doctor.

Eye Contact

Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for a duration of 30 minutes or until medical aid is available. Take care not to rinse contaminated water into the unaffected eye or onto the face. Skin Contact

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Small Fire: Dry chemical, foam, carbon dioxide, water-spray or alcohol-resistant foam. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Large Fire: Water spray, fog or alcohol-resistant foam.

Unsuitable Extinguishing Media

Do not use straight stream of water.

Specific Hazards Arising from the Chemical

Fire will produce irritating and corrosive gases. Containers may explode in fire.

Precautions for Firefighters

Isolate immediate hazard area and keep unauthorized personnel out. Stop spill/release if it can be done safely. Move undamaged containers from immediate hazard area if it can be done safely. Cool containers with flooding quantities of water until well after fire is out. Caution should be exercised when using water or foam as frothing may occur, especially if sprayed into containers of hot, burning liquid. Dispose of fire debris and contaminated extinguishing water in accordance with official regulations.

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Evacuate and isolate hazard area and keep unauthorized personnel away. Stay uphill and/or upstream. Ventilate closed spaces before entering. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing.

Protective Equipment

Wear chemical protective clothing and positive pressure self-contained breathing apparatus (SCBA). Wear liquid tight chemical protective clothing in combination with positive pressure self-contained breathing apparatus (SCBA).

Personal Precautions

Environmental Precautions

Methods and Materials for Containment and Cleaning up

SECTION 7) HANDLING AND STORAGE

General

Wash hands after use. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. Eyewash stations and showers should be available in areas where this material is used and stored All containers must be properly labelled. Do not get in eyes, on skin, or on clothing. Do not breathe vapor or mist.

Ventilation Requirements

Eye protection

Wear eye protection with side shields or goggles. Wear indirect-vent, impact and splash resistant goggles when working with liquids.

Skin Protection

Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product. Use of chemical resistant gloves classified under Standard EN374: Protective gloves against chemicals and microorganisms. Examples of preferred glove barrier materials include: Butyl rubber, Polyethylene, Chlorinated polyethylene, Ethyl vinyl alcohol laminate ("EVAL"). Examples of acceptable glove barrier materials include: Viton, Neoprene, Polyvinyl chloride ("PVC" or "vinyl"), Nitrile/butadiene rubber ("nitrile" or "NBR").
