SECTION 4) FIRST-AID MEASURES

Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. Get Medical advice/attention if you feel unwell. If exposed/lf you feel unwell/lf concerned: Call a POISON CENTER/doctor. Eliminate all ignition sources if safe to do so.

Eye Contact

If eye irritation persists: Get medical advice/attention. Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for a duration of 15-20 minutes. Take care not to rinse contaminated water into the unaffected eye or onto the face.

Specific Hazards Arising from the Chemical

Fire will produce irritating gases. Runoff may pollute waterways Most vapors are heavier than air. Stay uphill and/or upstream. Ventilate closed spaces before entering. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing. Evacuate and isolate hazard area and keep unauthorized personnel away. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). All equipment used when handling the product must be grounded. A vapor-suppressing foam may be used to reduce vapors.

Protective Equipment

Wear chemical protective clothing and positive pressure self-contained breathing apparatus (SCBA).

Do not breathe vapor or mist. Do not get on skin, eyes or clothing.

Environmental Precautions

Stop spill/release if it can be done safely. Methods and Materials for Containment and Cleaning up

General

Storage Room Requirements

Use non-sparking ventilation systems, approved explosion-proof equipment and intrinsically safe electrical systems in areas where this product is used and stored. Keep containers securely sealed when not in use. Containers that have been opened must be carefully resealed to prevent leakage. Indoor storage should meet OSHA standards and appropriate fire codes. Empty containers retain residue and may be dangerous. Store in cool, dry, well-ventilated areas away from heat, direct sunlight and strong oxidizers. Store in approved containers and protect against physical damage. Take precautionary measures against electrostatic discharge.
